Summer Program Summary

In the summer of 2013, Southwest Conservation Corp's Environmental Stewards Summer Program continued its excellent, ongoing work supporting environmental stewardship around the country. This summer we placed 52 AmeriCorps Members in 33 different sites located through-out the United States, including 4 people in the Commonwealth of Puerto Rico.

This report provides some of our accomplishments, along with a few spotlights of some of our Members. We look forward to expanding our program in 2014.

The following are some of the program accomplishments of 2013:



266 Acres of national parks, state parks, city parks, county parks and public and tribal communities were improved

24.3 miles of trails and rivers were improved and/or created

52 maps and 11 databases were maintained

556 volunteers were recruited, coordinated and supported


3961 volunteer hours were provided

1,000 surveys were conducted

123 water samples and 1,580 water quality readings were taken

Environmental education was provided to 211 adults and 444 students.

3,500 bird counts were conducted



Project Highlight: River Restoration in Inyo County, California



Environmental Steward Michael Bunn spent 10 weeks in the summer of 2013 providing service to the Inyo County Water Department.

Michael spent a good part of his time restoring the Owens River, which provides drinking water to the city of Los Angeles, provides irrigation to cattle, habitat for many plants and wildlife and recreation opportunities. Michael worked to manage unwanted emergent vegetation along the river. In creating a management plan, Michael worked with land managers, agricultural retailers, wildlife biologists, and recreationists. In addition, Michael created and organized a group of “community stewards” to take on the responsibility of keeping the Owens River managed for years to come.



Overall, Michael helped restore 10 acres of land and 5 miles of river, removing 10 tons of plant material and sowing tens of thousands of willow seeds in riparian areas.



Project Highlight: Restoring habitat with the USGS Great Lakes Science Center



Environmental Stewards Lizmar Rodriguez and Nelson Cordero both spent 10 weeks of their summer serving with the USGS – Great Lakes Science Center in Ann Arbor, MI. Lizmar and Nelson (both from Puerto Rico) focused their work on river conservation. Their project involved working with USGS on restoring habitat for native sturgeons. This includes taking samples of fish eggs, fish larvae and fish diet, water flow readings, acoustic telemetry observation, and adult Sturgeon size, weight and spawning behavior. Due to the unique partners in this project, and the excellent work the Stewards accomplished, this project was nominated for the 2013 *Secretary of the Interior Partners in Conservation Award*.
